* Families that are saving often have insufficient assets.

If a household uses all of this money to purchase an annuity from a life insurance company that will pay a guaranteed monthly income for the rest of the household's life, this income will provide only approximately \$5,000 per year in retirement nowhere near what the household is likely to need.

Not everyone is cut out to welcome Wal-Mart shoppers, fold clothes for ungrateful customers, or make fluffy drinks at the local coffee shop.




2. You could volunteer
